

### **INSTALLATION**




This unit must be installed by a licensed HVAC contractor. Failure to do so will void warranty of the product.




Never look directly at the ActivePure Bulb Assembly while illuminated. This Bulb produces UVC light which is known to cause damage to eyes.

 Remove film from one side of Velcro (2 pieces) and attach to the ActivePure Bulb Assembly as shown.




2. Remove film from opposite side of Velcro.



# **INSTALLATION (CONTINUED)**


 Find suitable location for the ActivePure Bulb Assembly, near the center of the coils. Clean area to remove grease or dirt. Place ActivePure Bulb Assembly to the attached Velcro.





- 4. Connect ActivePure Bulb Assembly wires to socket of ActivePure Bulb Assembly. These wires are a push connection; push until firmly seated. They are not connected when shipped to allow for more options in wire routing.
- 5. The Ballast Assembly is shipped with the voltage switch, located on the end of the ballast, pre-set to the 230V position. Ensure that the voltage switch, is set to the appropriate position for your application.


NOTE: The 230V setting is for 208 & 230V applications.


- 6. Attach Velcro to the Ballast Assembly using same method as above.
- 7. Mount Ballast Assembly in suitable location.













# **INSTALLATION (CONTINUED)**


8. Connect wiring assemblies to Ballast
Assembly using like colored wires as a guide.
(ie; red to red... etc.)





 Route power wires to the power connection terminals; connect the black wire to the S1 and the white wire to the S2



10. Dress all wires and replace cover.

For optimal performance, we recommend the replacement of the ActivePure® Bulb Assembly every year, even if the UV lamp appears to be operating normally.


Your Air Scrubber Mini by Aerus unit requires no periodic maintenance beyond normal replacement of the ActivePure® Cell Assembly.


# **DEFLECTOR SHIELD**

2. Rotate Shield as needed for proper alignment.



# WARRANTY INFORMATION

#### Limited Two (2) Year Warranty

Customer should not repackage and ship the Air Scrubber Mini by Aerus unit due to possibility of irreparable damage. For warranty service, please contact your Independent HVAC Contractor or call Customer Service at 866-736-0503.

#### WHAT IS COVERED BY THIS WARRANTY

We warrant the Air Scrubber Mini by Aerus to the Customer, subject to the conditions below, against defects in workmanship or material, provided that the products are returned to a service location within the following time periods:

- Air Scrubber Mini by Aerus (excluding ActivePure Bulb Assembly) within two (2) years of date of purchase.
- ActivePure Bulb Assembly within one (1) year of date of purchase if the Air Scrubber Mini by Aerus is connected to a power source where the ActivePure Bulb Assembly is "ON" 100% of the time. If the Air Scrubber Mini by Aerus is connected to the fan circuit where the ActivePure Bulb Assembly cycles "ON and OFF" with the system fan, the ActivePure Bulb Assembly is only covered by a ninety (90) day warranty from date of purchase.

### INSTALLATION AND MAINTENANCE REQUIREMENTS

This warranty is expressly conditioned upon proper installation, operation, cleaning and maintenance, all in accordance with the Owner's Manual. Failure to meet any of these requirements will void this warranty. This unit must be installed by a licensed HVAC contractor. Servicing of your Air Scrubber Mini by Aerus by parties other than our authorized representatives and/or using parts other than genuine parts will also void this warranty.

#### HOW TO OBTAIN WARRANTY SERVICE

Customer must contact their Independent HVAC Contractor and provide proof of purchase within the above time periods. We will repair or replace and return the product, without charge and within a reasonable period of time, subject to the conditions herein, if its examination shall disclose any part to be defective in workmanship or material. If we, in our discretion, are unable to repair the product after a reasonable number of attempts, we will provide either a refund of the purchase price or a replacement unit, at the company's option. We reserve the right to inspect and/or require confirmation of installation method.

### WHAT IS NOT COVERED BY THIS WARRANTY

Ordinary wear and tear shall not be considered a defect in workmanship or material.
