





The PureKooler is designed to be mounted onto the inside wall of a walk-in cooler, as high as possible.

The PureKooler is not a compressor, condensing unit, or evaporation unit.





- 1. Identify a discreet flat surface to accommodate the unit on the inside of the cooling unit.
- 2. Connect 120 VAC Power Cable to the black lead and white lead from the PureKooler, to the power source, according to local or national codes.
- 3. Use the provided cable clamp or appropriate type for local or national codes, to secure wiring connection to cover plate.



- 4. Screw the PureKooler into place using the (4) built-in mounting feet.
- 5. Once the unit is connected to the main power source the unit will operate 24/7, until it is removed from its power source.

### Replacing the ActivePure Cell Assembly



- · Service should only be performed by a qualified electrician
- · Make sure power to the unit is disconnected at the power source
- A face mask should be worn to prevent inhalation of any particles released into the air during any cleaning process; eye protection is also recommended



- For optimal performance and to maintain the Limited 3 year warranty, it is required to replace
  the ActivePure® Cell Assembly once every 12 months, even if the ActivePure Cell appears to be
  operating normally
- Use genuine AES replacement parts only; parts from anyone other than an authorized AES Representative may damage your unit and void your warranty

The only maintenance the PureKooler requires is replacement of the ActivePure Cell Assembly.

We recommend replacing the ActivePure Cell Assembly once every (12) months.

- 1. Disconnect power to the PureKooler.
- 2. Remove 4 screws from the Cover and slide the Cover away from unit. (Figure 1)
- 3. Unplug 4-pin Connector from the ActivePure Cell Assembly (red & blue leads). (Figure 2)
- 4. Remove 4 nuts from the ActivePure Cell Assembly brackets and remove the ActivePure Cell Assembly. (Figure 3)
- 5. We recommended vacuuming off the vent openings to remove any dust build-up.

NOTE: A face mask should be worn to prevent inhalation of any particles released into the air during any cleaning process. Eye protection is also recommended.




## Replacing the ActivePure Cell Assembly (continued)

- 6. Slide the new ActivePure Cell Assembly into place. Note the orientation of ActivePure Cell Assembly in relation to the Fan. (Figure 4)
- Reinstall 4 nuts to secure ActivePure Cell Assembly into place. (Figure 5)
- Reconnect 4-pin Connector to ActivePure Cell Assembly.
   (Figure 6)
- 9. Slide the Cover back onto the unit. (Figure 7)
- 10. Reinstall 4 screws to secure Cover. (Figure 7)
- 11. Reconnect power.
- 12. Verify the new ActivePure Cell Assembly is working by looking for a glow from the vent exhaust opening.

  of date of purchase.
- ActivePure Cell Assembly (Qty 1) within (12) months from the date of purchase.
